

## **Invasive Species Treatments**

The Lake John Improvement District has continued the fight in keeping our lake free of Invasive Species. A CLP treatment was done in June at a cost of \$6,878.25. Eurasian watermilfoil was assessed at a cost of \$900, and treated for \$1,690.00 in July. We are still free of Starry stonewart, but to be certain, LID is testing twice a year. An assessment was done in July and again in September at a cost of \$850.00 per instance.

## **Bogs**

The loose bog saga continues. We did obtain a permit to remove two bogs; one 20'x20' and one 35'x35'. We were graciously given permission by Adelle Seanor to dispose of the bogs on her property. Last we have an excavation company ready to do the work. What's the hold up then you ask. Several factors need to be in our favor for removal. The bogs need to be loose and in a place boats can get to them to push them to a landing site. Also the wind has to have died down to make it feasible to push them where they need to go. If everything aligns, we do still plan to have them removed.

#### Septics and lake health

Did you know that roughly a third of MN homes have a septic system? Most comply with state regulations, but in 2018 MN Pollution Control estimated that 15% of systems do not meet current regulations for protecting our groundwater. This is especially worrisome near lakes and rivers. When a septic system fails or even leaks, they can be a major source of phosphorus which fuels algae blooms. "Failing septic systems can have a huge impact on water quality, and it doesn't take many of them," said Jeff Forester, executive director of MN Lakes and Rivers Advocates. So please, have your septic systems inspected and pumped every few years by a professional. If you don't have a drain field your septic tank will need to be pumped several times a month or more depending on usage.


